



He could solely sustain himself by operating as a street vendor of herbal medication. The liberty of thought and action is essential for every human, regardless of gender. Regrettably, they exploited that freedom. Following precisely 24 hours in each other's company, Drigo departed and never reentered Giana's life. Throughout her three marriages, she experienced abandonment by those she cherished, a consequence of her life history. Giana experienced adultery in her relationship; but, her romantic setbacks did not deter her from pursuing a new life.

Minar, Giana's mother, possesses a narrative akin to Giana's. She was betrayed by the man she loved in an extramarital affair. Minar was secretly pregnant with Arkan's child from their illicit connection. The description indicates that construction is characterized as the overarching element that creates the issues inside the narrative. Gender inequality refers to the disparity in treatment or opportunities based on gender. The presence of gender inequality will lead to differences in familial and communal life. Moreover, gender inequality constitutes a system and structure that victimizes both men and women. Gender disparity predominantly affects women, resulting in their continued discriminatory status in social life, which adversely impacts them.
